Also, a few other things to be aware of:

- If you feel you require accommodations for your summer/fall 2023 classes and/or throughout your time at UMW, please complete the <u>Registration Form</u> and provide appropriate <u>documentation</u>. The **Office of Disability Resources** (ODR) has been designated by the University of Mary Washington as the primary office to guide, counsel, and assist students with disabilities. ODR specialists will work diligently to provide you appropriate accommodations starting summer 2023.
 - If you are in need of <u>Housing Accommodations</u> throughout your time at UMW, please complete the required <u>registration form</u> and provide your <u>Housing Accommodation Request</u>
 <u>Form</u> as soon as possible. Should you have questions, or specific needs around housing, ODR also recommends you contact their office at 540-654-1266.
- If possible, please submit your 'Health History' documentation to the UMW Health Center prior to arriving to campus for the STP summer experience. The forms can be located in the health center's 'Student Portal' highlighted in yellow on the left-side of their website; you can access the portal through the following link.
 - You are **NOT** required to have this documentation on file to participate in the STP summer program. However, in the event that you may need to visit the UMW Health Center during the two-week summer program, it is helpful for their staff to have your information available.
- You will be enrolled in your two summer courses in the coming days. Once enrolled, you'll be able to see
 the courses in Banner. If for any reason you receive messaging about a bill on your student account for
 the summer courses, please let me know. You are **NOT** responsible for the cost of your summer courses
 and/or textbook.

Reminder, move-in will take place between 12:00noon-3:00 pm. You will report directly to Virginia Hall via the Monroe Circle (i.e., Campus Drive). To access Campus Drive, you will need to enter campus via Sunken Road. When you arrive at the Monroe Circle, there will be staff directing traffic for drop-off. At 3:00 pm, the summer counselors will begin to walk STP participants over to the location of the Welcome Ceremony.

Lastly, you should have received my initial welcome message weeks ago, which contained lots of pertinent information about the summer program.
